Purpose:

The purpose of this supplemental filing is to revise tariff Schedule No. H-1 and CA-4, previously submitted to the CPUC for approval on June 24, 2020.

On June 24, 2020, California American Water filed AL 1299 to incorporate Hillview Water Company (“Hillview”) rates, rules and service area maps into California American Water’s tariffs. In its original filing, California American Water inadvertently omitted rates for 8-inch private fire protection service connections for the Hillview service area on Schedule No. CA-4. California American Water also carried over language onto Schedule No. H-1 from the previously approved Hillview tariffs for Surcharge #3, 4, and 5. While Hillview tariffs embedded these previously approved surcharges into their service charges, California American Water chose to separate these surcharges out as separate line items on customer bills for greater transparency to customers.

Background:

April 25, 2018, California American Water filed Application (“A.”) 18-04-025 requesting the approval of the sale of Hillview Water Company, Inc. (“Hillview”) to California American Water. The Commission approved the transfer of ownership in Decision (“D.”) 19-11-003. California American Water closed the sale on June 24, 2020 and filed AL 1299 to incorporate Hillview’s rates, rules and service area maps into California American Water’s tariffs.

Requests:

California American Water requests revisions to pending Tariff Schedule No. H-1 & CA-4. California American Water requests to include rates applicable to 8-inch private fire service connections for the Hillview service previously omitted in its original AL filing. California American Water also requests to revise the language pertaining to previously approved Surcharge #3, 4 & 5 on Schedule No. H-1 to clarify that surcharges are to be called out separately on customer bills rather than remain embedded into the service charge.

Protests and Responses:

Anyone may respond to or protest this advice letter. When submitting a response or protest, **please include the utility name and advice letter number in the subject line.**

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A **protest** objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds¹ are:

1. The utility did not properly serve or give notice of the AL;
2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
3. The analysis, calculations, or data in the AL contain material error or omissions;
4. The relief requested in the AL is pending before the Commission in a formal proceeding;
or
5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
6. The relief requested in the AL is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require relitigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

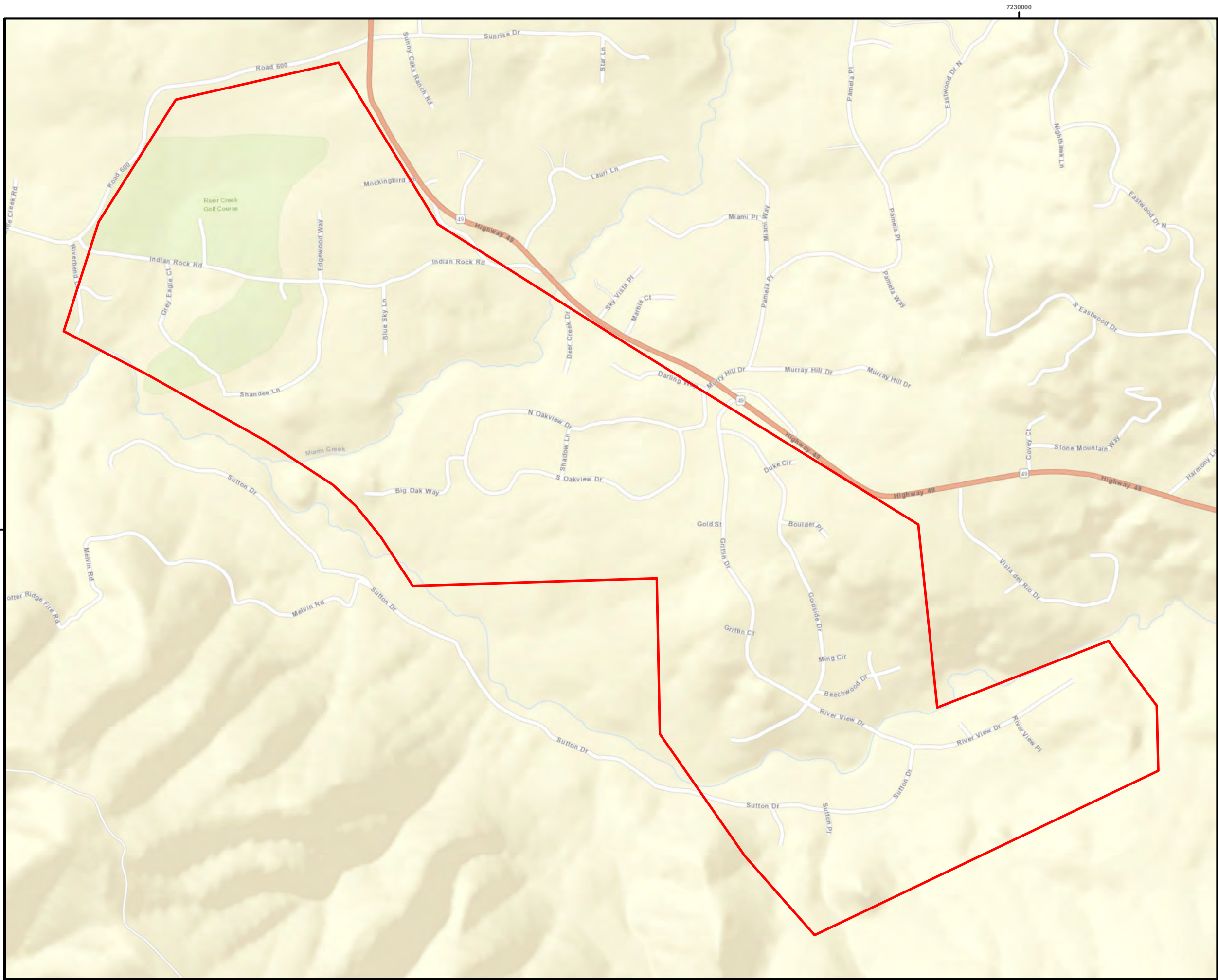
Service Area Map

 Service Area Boundary



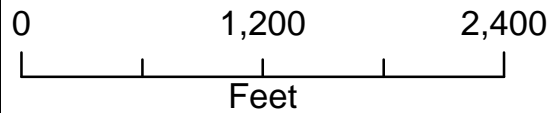
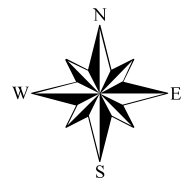


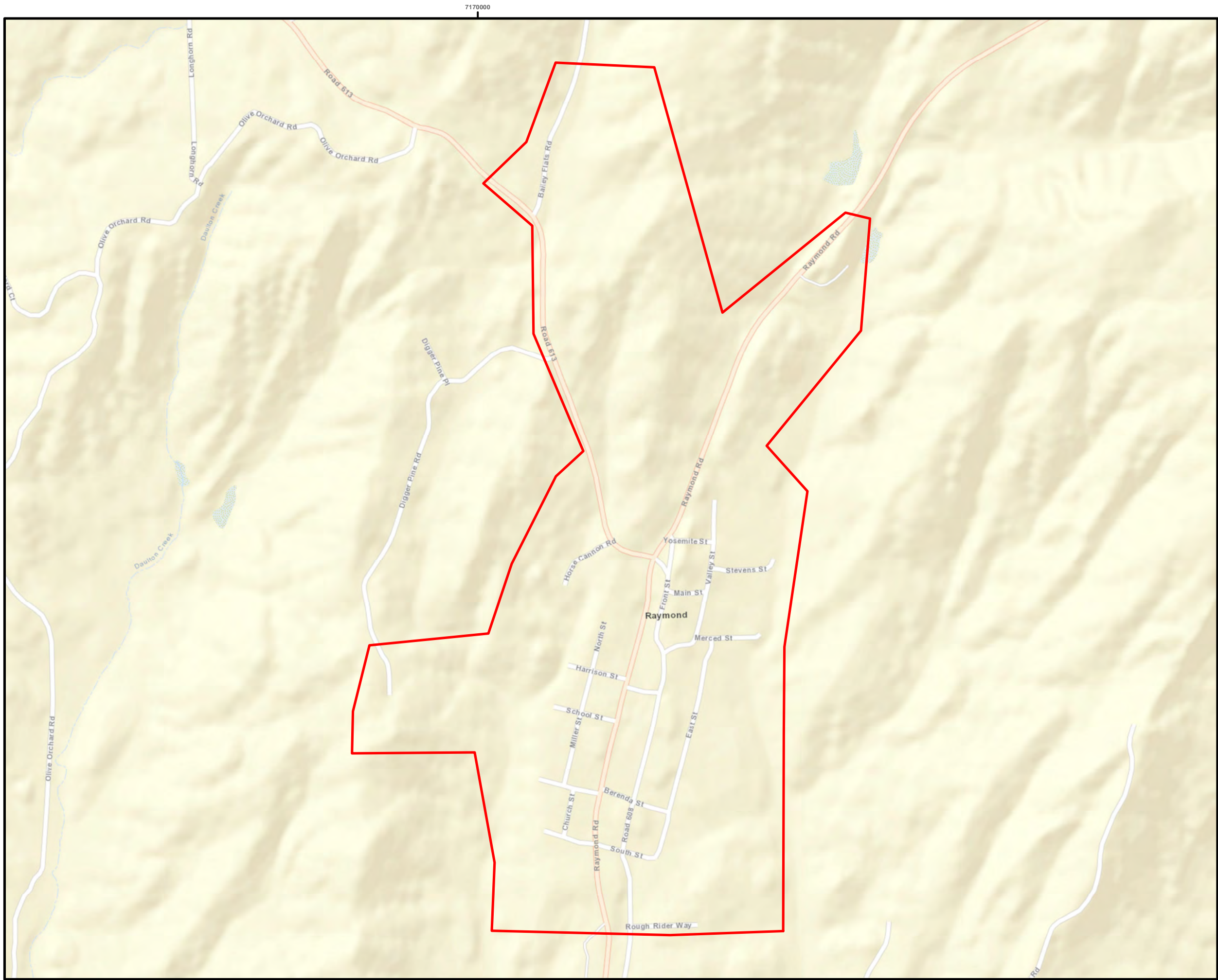
Service Area Map

 Service Area Boundary



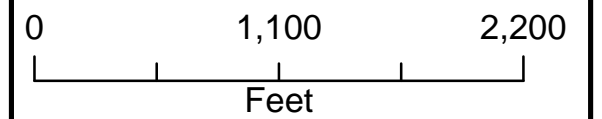


Service Area Map

The fee shall be applied at the time a late payment notice is issued. If the Customer pays the balance on the date the late payment notice is mailed then that assessed fee will be forgiven. The fee shall be assessed on all open balances regardless of whether it is an initial or subsequent bill when a total balance has not been paid or there should have been a shut off for non-payment agreement. All bills shall be subject to the PUC reimbursement fee as set forth in Schedule No. UF.

Reconnection Fee: Where service has been discontinued for violation of these rules or nonpayment of bills, the Utility may charge \$10.00 for reconnection of service during regular work hours or **\$150.00** for reconnection of service at other than regular working hours when the Customer has requested that the reconnection be made at other than regular working hours. If payment is received after 3:00PM, service will not be restored until the next business day. All bills shall be subject to the PUC reimbursement fee as set forth in Schedule No. UF.

Untested Backflow Fees: Where the Utility elects to have an untested backflow assembly tested and, if needed, repaired or replaced, all charges incurred by the Utility from third party service providers will be added to the Customer bill of the account of record, and shall become due and payable as any other charge, including being part of any unpaid balance subject to late fees and discontinuance of service for non-payment.
